2020 Nomination Process for Individuals

To be considered for the 2020 Raleigh Hall of Fame,
the Nominees must meet the following criteria:

1. The Nominee must have made a significant and noteworthy contribution to the City of Raleigh. Relevant considerations include civic, business, and professional accomplishments.
2. The Nominee may be living or deceased.
3. The Nominee's achievements must have enduring value and lasting importance.
4. Members of the Board of Directors of the Raleigh Hall of Fame and the Advisory and Selection Committees, and members of their immediate families, are not eligible for induction while serving in such capacity and for a period of two (2) years thereafter.

TO NOMINATE AN INDIVIDUAL FOR INDUCTION INTO THE RALEIGH HALL OF FAME, PLEASE COMPLETE THE ATTACHED NOMINATION FORM AND SUBMIT A STATEMENT explaining the significance and value of the contribution(s) the Nominee has made to Raleigh.

The statement should be no more than three pages, double-spaced. Please include pertinent information that supports consideration of your candidate. This includes, without limitation, supporting letters from others, as well as materials that directly attest to the nominee's contributions, achievements and character.

- **Effectiveness** – How did the actions of this person affect Raleigh? Are we a better City for these efforts? Did they contribute in a way that still affects us today? Did his/her contribution(s) help distinguish Raleigh throughout the state and/or nation? Please provide an example(s) and explain.
- **Years of Service to Raleigh** – Over what period of time did this person make his/her contribution(s)? Has his/her contribution(s) had a cumulative and continuing effect? Please provide an example(s) and explain.
- **Leadership** – Was this person a trailblazer? Did he/she face or overcome adversity to reach his/her goals? Was he/she a role model for others? Please provide an example(s) and explain.
- **Impact on Raleigh** – How did his/her contribution(s) make a lasting and significant impact on Raleigh? Please provide an example(s) and explain.



The three page double-spaced statement (as referenced above) and supporting letters and documents cannot exceed 15 pages. All materials that are submitted will become the property of the Raleigh Hall of Fame and will not be returned. Please note that statements provided in support of the nomination may appear in the Raleigh Hall of Fame's printed materials and on its website.

Additional supporting material that documents and directly attests to the nominee's contributions, achievements and character may be included.

- Supporting letters or documents will be accepted. Letters and supporting documents should address at least one of the following categories: Effectiveness, Years of Service, Leadership, and/or Impact on Raleigh.
- While nominations may be submitted by members of a nominee's family, letters of support should be written by persons unrelated to the nominee.

Responsibilities as Nominator

If your nominee is chosen for induction, you or a designee will be requested to be the Nominator/Partner to the Raleigh Hall of Fame induction process which includes:

- designating a person to do a video interview for the induction ceremony and providing additional information and photos for that video and the ceremony program;
- attending the Partner's Breakfast (early June) at which a package of information will be distributed detailing the Induction Ceremony;
- assisting in providing biographical and other information necessary to promote the event and your inductee.
